

Food trucks are being invited to participate with two payment options:

- 1: No up-front payment. Instead, 10% of gross sales will be required as payment at the end of the event. OR**
 - 2. A flat fee payment of \$250.**
- You will pay the greater of the two amounts, either 10% or \$250..**

All beverages will be sold by the Pacific Rim Street Fest Committee. Food vendors will sell food items only.

Vendors will be responsible for providing all required equipment—including a fire extinguisher that meets current fire codes—and must comply with the Health and Safety Code before food is permitted to be served. *Please note: if a Health Department re-inspection or any other fee-based service is required, funds will be deducted from your security deposit.*

Refund Policy: If a vendor cancels prior to the event, the refund schedule is as follows:
Up to 90 days prior to day of event - 75%, Up to 30 days prior to day of event - 25%
Up to 60 days prior to day of event - 50% Less than 30 days - 0%

All requests for refunds must be made in writing and are subject to approval by the PRSF Planning Committee.
